Terms & Conditions

GENERAL CONDITIONS

- The C&C Protector Program for DS must be purchased with the DS Care Service Plan.
- Service credits and accessories credits are not allowed to be used to purchase the C&C Protector Program for DS.
- Customer has the option to purchase the 1-year/25,000km or 2-year/50,000km C&C Protector Program for DS, provided that the previous warranty program is still live.
- Car age must be between 48 months to 60 months old at time of purchase and mileage not exceeding 100,000km.
- The C&C Protector Program for DS is non-refundable, but is transferable to the next owner of the same car.
- The C&C Protector Program for DS is only available for privately-owned cars. Not applicable for company registered cars, private hire cars or fleet car owners.
- Cycle & Carriage France Pte Ltd reserves the right to exclude or include any specific vehicle models from the C&C Protector Program for DS at any point in time.
- The coverage of any vehicle under the DS Protector Program shall be limited to within Singapore. For the avoidance of doubt, the vehicle may also be driven to Peninsula Malaysia and up to 200km beyond the southern borders of Thailand but any repair occurring outside of Singapore shall not be covered under this Program, unless vehicles are repaired by Cycle & Carriage France Pte Ltd.
- Cycle & Carriage will bear the repair and replace the covered components under mechanical & electrical failure for any one claim up to the current market value of the vehicle or the purchase price of the new vehicle at the point of sale (excluding taxes and the Certificate of Entitlement).

GENERAL EXCLUSIONS

Cycle & Carriage France Pte Ltd shall not be liable under C&C Protector Program for DS for: -

1. Preventive Maintenance

The cost of establishing preventive maintenance procedures or the cost of recall by the manufacturer of any vehicle or any part thereof, nor the cost of alterations, additions, improvements or overhauls.

2. Consequential Loss

Loss of use or any other consequential loss, penalties for delay or detention, or in connection with guarantees of performance or efficiency.

3. Other Insurance or Warranty

Any defects in workmanship and materials which is claimable under the terms of any other Insurance, Warranty or Manufacturer's Warranty.

4. Excluded Use

Any vehicle:

a) used for competitions, racing, pacemaking, off-road use, the provision of a short-term self-drive contract, as a taxi or by a driving school, a dispatch or delivery courier or for any form of commercial use, hire or reward (excluding private hire arrangements or single-user vehicle leasing arrangements).

b) used for public services (such as but not limited to police, fire brigade, ambulance, rescue, military purposes)

5. War and Terrorism Exclusion

Loss, damage, cost or expense of whatsoever nature directly or indirectly caused by, resulting from or in connection with any of the following regardless of any other cause or event contributing concurrently or in any other sequence to the loss;

a) war, invasion, acts of foreign enemies, hostilities or warlike operations (whether war be declared or not), civil war, rebellion, revolution, insurrection, civil commotion assuming the proportions of or amounting to an uprising, military or usurped power; or

b) any act of terrorism.

For the purpose of this endorsement an act of terrorism means an act, including but not limited to the use of force or violence and/or the threat thereof, of any person or group(s) of persons, whether acting alone or on behalf of or in connection with any organisation(s) or government(s), committed for political, religious, ideological or similar purposes including the intention to influence any government and/or to put the public, or any section of the public, in fear.

This endorsement also excludes loss, damage, cost or expense of whatsoever nature directly or indirectly caused by, resulting from or in connection with any action taken in controlling, preventing, suppressing or in any way relating to (a) and/or (b) above.

Where Cycle & Carriage France Pte Ltd alleges that by reason of this exclusion, any loss, damage, cost or expense is not covered by this warranty program the burden of proving the contrary shall be upon the Customer.

In the event any portion of this exclusion is found to be invalid or unenforceable, the remainder shall remain in full force and effect.

3. Fair wear and tear of any part, normal deterioration, discoloration, fading, flawing, aging or damage to plated parts, paint coat, rubber parts, upholstery, leatherette and soft trim caused by daily use, wear and exposure, panels (e.g. front and rear quarter panels, door panels, roof, bonnet/hood, boot/tailgate, etc.), bodywork and its components (e.g. bumpers, lamps, lenses, chassis and sub-frames, roof bars/rails).
4. Minor irregularities not affecting quality, performance or function of vehicle or parts thereof (e.g. slight noise or vibration) or which appear only in particular abnormal operations.
5. Damage caused by insufficient or improper repair or maintenance (e.g. negligence of the daily and periodic inspection services and maintenance as recommended by the manufacturer of the Vehicle)
6. Damage caused by using a part not approved by Cycle & Carriage France Pte Ltd or Vehicle Manufacturer and being repaired or replaced by any person or any entity other than Cycle & Carriage France Pte Ltd or authorised repairers.
7. Damage caused by traffic accidents, impact, abuse or negligence of the proper handling, misuse of the Vehicle, use of the Vehicle under unusual conditions such as races, rallies and/or driven closed circuit tracks, and modifications of or to the Vehicle or any components/parts thereof not recommended or approved by the Insured.
8. Damage caused by external influences such as chemical pollution, acid rain, tree sap, bird droppings, insects hail, sand, salt, stones, road hazards, lightning, floods, fire or disaster whether due to human fault, negligence or Act of God.
9. Damage in cargo body or cargo cabin by loading or incorrectly secured goods during transit.
10. Incidental or consequential damages such as loss of use of the Vehicle, loss of time, expenses for fuel, telephone, travel, lodging, legal fees, transportation loss or damage to personal property or commercial loss or loss of revenue
11. Any Vehicle for which the odometer reading has been altered so that the actual mileage cannot be readily determined.
12. Incorrect fuels, fluids and lubricants that are not approved by the Insured or any loss or damage caused by the use of contaminated fuel.
13. Damage caused by irresistible reasons such as war, invasion, act of foreign enemy, civil war, rebellion, revolution, riots, military and usurped power, terrorism, nuclear risk, fire, theft, etc, or from any other external cause.
14. Vandalism.
15. Glass damage, if it is not clearly proven that this is due to manufacturing or installation errors.
16. Any Mechanical & electrical failure or costs covered by any other warranty or entitlement (including the manufacturer's vehicle warranty);
17. Any Mechanical & electrical failure attributable to the failure to comply with the 'Vehicle Service Requirements'.
18. Any repairs required as a result of continued operation of the Vehicle once a defect or fault has occurred (including loss of lubricants and/or coolant);
19. Any towing or the cost to send the Vehicle to or take the Vehicle back from an Authorised dealer, or other salvage expense, or loss of time, inconvenience, or commercial loss, or any other direct or indirect loss or any other consequential loss, penalties for delay or detention, or in connection with guarantees of

performance or efficiency, damage or liability incurred as a result of a Mechanical & electrical failure (including personal liability);

20. Consequential damage to a component not covered as a result of the failure of a Covered component, and/or damage to a Covered component caused by the failure of a non-covered component;

21. Any claim where the Mechanical & electrical failure has been caused by abuse/misuse of the Vehicle;

22. Any loss or damage of whatsoever nature arising directly or indirectly in whole or in part due to any act of omission by the Owner which is wilful, unlawful or negligent;

23. Any claim attributable to failure to follow the Vehicle manufacturer's operating guidelines (located in the Owner's manual) or Mechanical & electrical failure attributable to exceeding the manufacturer's operating limitations;

24. Any recall or campaign costs on the Vehicle instigated by the manufacturer;

25. Any claim arising from the Mechanical & electrical failure of a Covered component which has, prior to the Mechanical & electrical failure, been repaired by any person other than Cycle & Carriage France Pte Ltd.

26. Any Mechanical & electrical failure that can be attributed to the Vehicle being fitted with an alternative fuel unit other than a unit supplied, fitted or endorsed by the Vehicle manufacturer.

27. The cost and expense to test or replace parts as required by government authority.

28. Any claim due to normal wear, corrosion, rust, or other gradual loss or reduction of function.

29. Any components which have not broken down but are replaced during the course of the repair of a covered Mechanical & electrical failure.

30. Any costs that arise as a result of faults in workmanship or materials in respect of repairs.

31. Loss, damage, cost or expenses of whatsoever nature directly or indirectly caused by collision, overturn, parallel falls, the collapses of external objects, the falls of moving object in air incurred while the Vehicle is moving or parking, pressure waves caused by aircraft or other aerial devices travelling at sonic or supersonic speeds.

32. Any costs relating to noise and/or vibration due to parts being worn out, excessive free play or poor insulation.

33. Any costs relating to seals and/or gaskets leaking alone.

34. Any loss, damage or failure, which existed prior to the start of the extended warranty.

35. Parts with a use-by date e.g. first aid kit, Tirefit etc.

36. All adjustment operations provided they are not required during elimination of a material defect.

37. Any component of the Vehicle not specifically listed as a Covered component.

38. Your warranty may become invalid if you continue to drive when a fault becomes apparent.

In the event any portion of this exclusion is found to be invalid or unenforceable, the remainder shall remain in full force and effect.

7. odometer reading cannot be determined as accurate by virtue of it having been inoperative or removed from the Vehicle; and
8. is unroadworthy or unregistered.
9. is being used outside of the Republic of Singapore

VEHICLE SERVICE REQUIREMENTS

It is a condition of the warranty that the Customer shall have the vehicle properly, regularly and punctually serviced in accordance with the manufacturer's recommendations by Cycle & Carriage France Pte Ltd or any other reputable workshop. This servicing must be carried out in accordance to the manufacturer's recommended interval of 10,000km or 6 months, whichever occurs first, or such other intervals as specified by the manufacturer of the Vehicle. If the Vehicle is not serviced by Cycle & Carriage France Pte Ltd, the Customer may be required to provide proof of servicing in the event of a claim.

TRANSFERABILITY

In the event that the Customer sells the Vehicle, the extended warranty is transferable to new owners of the Vehicle provided that the change in ownership is registered by the new owner in Cycle & Carriage France Pte Ltd records. This is provided that the transfer is made at a private and individual basis and not sold to or through a non-authorized dealer or motor trader.
